**CANCELLATION / REFUND POLICY / PENALTIES** - Any cancellations made within **50** to **16** days of departure that may be entitled to a refund of recoupable expenses will be processed after the group has traveled and the trip has been audited at the end of our travel season. **15 DAYS OR LESS, FULL FORFEITURE OF ALL MONIES RECEIVED. IF NON-REFUNDABLE DEPOSITS ARE MADE FOR YOUR GROUP PRIOR TO DEADLINES, IT CANNOT BE REFUNDED.**

**Dismissal** - We reserve the right to refuse to retain any participant on the tour. No refund will be issued to any member who is dismissed. Expenses incurred by the individual after dismissal are the responsibility of that individual only and not the sponsoring organization or Educational Tours, Inc. (The undersigned agrees that students are aware that normal "School Rules" are in effect while on tour.)
